SUPERIOR COURT OF THE DISTRICT OF COLUMBIA ADMINISTRATIVE ORDER 24-11

Reestablishment of the CJA/CCAN Investigator Panel Members

(Supersedes Administrative Order 23-26)

WHEREAS, the Plan for Furnishing Representation to Indigents under the District of Columbia Criminal Justice Act and the Plan for Furnishing Representation in Neglect Proceedings in the District of Columbia provide for the appointment of qualified investigators; and

WHEREAS, Administrative Order 02-13, issued on April 12, 2002, adopted the Guidelines for Investigators in the Superior Court of the District of Columbia ("Investigator Guidelines") to govern persons certified to receive payment for investigative services under the Criminal Justice Act ("CJA") and Counsel for Child Abuse and Neglect ("CCAN") Program; and

WHEREAS, Administrative Order 02-24, issued on August 1, 2002, designated the members of the CJA/CCAN Investigator Panel and instituted training and recertification requirements for CJA/CCAN investigators; and

WHEREAS, Administrative Order 10-14, issued on September 28, 2010, amended the Investigator Guidelines and created the CJA Investigator Panel Advisory Program Committee to oversee the selection and recertification of CJA/CCAN investigators; and

WHEREAS, the Investigator Guidelines, as amended by Administrative Order 10-14, and as further amended by Administrative Order 12-17, issued on November 29, 2012, require the reestablishment of the CJA/CCAN Investigator Panel every four years beginning October 1, 2010; and

WHEREAS, Administrative Order 14-16, issued on September 25, 2014, reestablished the CJA/CCAN Investigator Panel as required; and

WHEREAS, Administrative Order 18-13, issued on September 27, 2018, reestablished the CJA/CCAN Investigator Panel as required; and

WHEREAS, Administrative Order 18-13 permitted identified Investigators to be on the CJA/CCAN Panel on a temporary basis until December 31, 2018 due to the delay in the FBI returning their background checks; and Investigators identified therein for whom the Public Defender Services (PDS) Office did not receive an FBI background check by December 31, 2018 would forfeit their certification and be removed from the final Administrative Order; and

WHEREAS, Administrative Order 19-02, issued on February 1, 2019, recertified the CJA/CCAN Investigator Panel as required; and

WHEREAS, Administrative Order 22-32, issued on November 1, 2022, recertified the CJA/CCAN Investigator Panel as required; and

WHEREAS, Administrative Order 22-32 permitted members of the CJA/CCAN Investigator Panel established by Administrative Order 19-02 to remain on the Panel, subject to the requirement that they submit a complete certification of good standing to the Office of Public Defender Service by October 31, 2022, and submit updated FBI and Local Background results no later than June 30, 2023, absent further extension of the deadline for submission; and

WHEREAS, Administrative Order 23-11, issued on June 9, 2023, certified an emergency opening of the CJA/CCAN Investigator Panel to obtain additional quality investigative services through the period of June 9, 2023, through August 31, 2023; and

WHEREAS, Administrative Order 23-26, issued on November 15, 2023, certified the addition of four (4) new members to the existing CJA/CCAN Investigator Panel Administrative Order 22-32; and

WHEREAS, it is in the best interest of the administration of justice for the CJA/CCAN Investigator Panel to be reestablished at this time;

NOW, THEREFORE, it is by the Court,

ORDERED, that the CJA/CCAN Investigator Panel is hereby finalized, effective October 1, 2024; and it is

FUTHER ORDERED, that the persons listed in the attachment to this order are now designated as members of the CJA/CCAN Investigator Panel, effective October 1, 2024.
