**Report of the D.C. Judicial Nomination Commission

Judicial Nomination Commission Tracy Nutall, Executive Director, Marie Johns, Chair, and Yaida Ford, Commissioner presented an overview of the Commission's role in selecting, evaluating, and recommending judicial candidates for vacancies on the D.C. Superior Court and the D.C. Court of Appeals. Ms. Nuttall and Ms. Johns emphasized that the D.C. Bar has an important role in the judicial nomination process to help create the strongest pool of judicial applicants for both courts.

**Annual Report of the Legal Ethics Committee
