**Remarks and Swearing-in of the Board of Governors  
by the Chief Judge of the D.C. Court of Appeals  
and Remarks by the Chief Judge of the Superior Court  
of the District of Columbia  
(Agenda Items 2 and 3)**

Chief Judge Blackburne-Rigsby thanked outgoing President Susan M. Hoffman for her leadership, especially during the COVID-19 pandemic and other significant recent events. She expressed her appreciation for the efforts of the Bar to help ensure access to justice during these difficult times. She discussed court administration issues, vacancies on the D.C. Court of Appeals, the cancellation of the July bar exam, initial efforts to administer an in-person UBE in September, and the decision ultimately to offer the bar exam remotely in October.

Chief Judge Robert Morin also thanked Immediate-Past President Hoffman for her work and leadership and welcomed incoming President Klineberg. He discussed the challenges of the pandemic, including issues of digital access in the Superior Court. He acknowledged the valuable partnership he has had with Chief Judge Blackburne-Rigsby.

Chief Judge Blackburne-Rigsby administered the oath of office to the 2020-21 Board of Governors and Officers.

### **Proposal to Amend Article VI of the D.C. Bar By-laws to Change Composition of the Audit Committee (Agenda Item 9)**

President Klineberg reported that the Bar's auditors recommended that the Immediate-Past President no longer serve on the Audit Committee. President Klineberg recommended an amendment to the By-laws to incorporate that recommendation, which was approved by the Board. The amended By-law reads as follows:

## **Article VI—Committees**

### **Audit**

The Audit Committee shall consist of three members of the Board the majority of whom have completed at least one year of service on the Board, and two persons who, by virtue of training and/or occupation, are knowledgeable about finance and audits, all of whom are appointed by the President with the approval of the Board to staggered three-year terms. The Immediate-Past President and Treasurer shall not serve on the Audit Committee. *[Amended July 14, 2020]*

### **Proposal to Suspend Article III, Section 2 of the D.C. Bar By-laws to Waive the Penalty for Late License Fee Payment (Agenda Item 10)**

President Klineberg recommended that, in the light of the economic downturn brought on by the current COVID-19 pandemic, the Board suspend Article III, Section 2 of the By-laws that provides for the imposition of a \$50.00 penalty for late payment of license fees, and to grant to CEO Spagnoletti and the membership office the discretion to waive the fee during the 2020-21 Bar year only for any member claiming hardship as a result of the pandemic. The By-law states, in relevant part:

**ARTICLE III—Dues [license fees] and Registration: Suspension and Reinstatement**

**Section 2. Administrative Suspension for Nonpayment of Dues [license fees]**

- a. If the annual dues of any member have not been received by July 15 of the year in which the dues are due and payable, the Treasurer or his/her delegate shall send on forthwith to the member notice that his/her dues have not been paid, that a late charge of \$50.00 has been added to the unpaid dues, and further, that unless any unpaid late charges and any unpaid dues are received by September 30, the membership of such member shall be, and hereby is, automatically suspended administratively pursuant to this Section....

The Board approved the recommendation.
